The Stopping-up of Highways (Part of Un-named Lane, Cemetery Road, Porth, Rhondda Cynon Taff) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highway described in the Schedule to this notice to enable development consisting of the construction of a private garage, for which planning permission has been granted, to be carried out.

SCHEDULE

The highway to be stopped up is at Porth, in the County Borough of Rhondda Cynon Taff. It is shown by zebra hatching on the deposited plan and is that length of the un-named lane which extends from a point 8 metres north-west of its junction with the footway of Cemetery Road for a distance of 10 metres and is 1.5 metres wide.
