## DEPARTMENT OF THE ENVIRONMENT

### WATER INDUSTRY ACT 1991, SECTION 19(1)(b)

Consumers in Bridgend and the surrounding areas who might be affected by improvement work being carried out by Dŵr Cymru Cyfyngedig at its Cefn Hirgoed No. 1 Service Reservoir will wish to be aware of the following information.

Although the water has at all times been, and remains, safe to drink, the Company has found from its water quality monitoring programme that water supplied from this reservoir has on occasion not met the standard for total coliforms (as required by the Water Supply (Water Quality) Regulations 1989).

The Company gave the Secretary of State a legally binding undertaking on 3rd October 1989, to carry out appropriate remedial work to be completed by the year 2000. However, the timescale of this undertaking is no longer considered appropriate, and the Company has submitted a further undertaking, with a revised completion date of 31st March 1997.

The Secretary of State is satisfied that the Company is complying with this new agreement and has informed the Company that he is satisfied by serving on them the notice printed below:
