### TOWN AND COUNTRY PLANNING ACT 1990

### HIGHWAYS ACT 1980

#### *The Stockton-on-Tees Borough Council (A1305 Allison Street/Nelson Terrace Stockton-on-Tees) Side Roads Order 1995*

The Secretary of State for Transport hereby gives notice that he has confirmed, with modifications, the above-named Order which was made by Stockton-on-Tees Borough Council ("the Council") under sections 14 and 125 of the Highways Act 1980 and which as confirmed would authorise the Council to:

- improve highways;
- stop up highways;
- construct new highways;
- stop up private means of access to premises;
- provide new means of access to premises;

and on or in the vicinity of the classified road, namely the A1305 which the Council propose to construct from a point 73 metres north of its junction with Bishopton Lane for a distance of 445 metres in a south-westerly, southerly, then south-easterly direction to a point 153 metres north of its junction with Dovecot Street; and the A1305 Nelson Terrace which the Council propose to improve from a point 153 metres north of its junction with Dovecot Street to its junction with Dovecot Street.
