The A41 London to Birmingham Trunk Road (Aston Clinton Bypass) Compulsory Purchase Order (No. SW14) 1997

The A41 Trunk Road (Aston Clinton Bypass) Supplementary Compulsory Purchase Order (No. SW13) 1997

Notice is hereby given that the Secretary of State for Transport in exercise of the powers conferred on him by the above-mentioned Acts has made Compulsory Purchase Orders, entitled as above, authorising him to purchase compulsorily the land and rights described in the Schedules hereto for the purpose of:

- (i) the construction of the new trunk road at Aston Clinton in the Parishes of Weston Turville, Aston Clinton, Buckland, and Drayton Beauchamp in the District of Aylesbury Vale, in the County of Buckinghamshire, in pursuance of the A41 London to Birmingham Trunk Road (Aston Clinton Bypass and Slip Roads) Order 1991;
- (ii) the constuction and improvement of highways and the provision of new means of access to premises at Aston Clinton in the said Parishes, District and County in pursuance of the A41 London to Birmingham Trunk Road (Aston Clinton Bypass and Slip Roads Slide Roads) Order 1996 and the A41 Trunk Road (Aston Clinton Bypass Side Roads) Supplementary Order 1996;
- (iii) the improvement of the A41 London to Birmingham Trunk Road at Aston Clinton in the said Parishes, District and County;
- (iv) the diversion of a navigable watercourse, the partial diversion of the Grand Union canal (Wendover Arm) and the execution of other works on watercourses in connection with the construction of the new trunk road;
- (v) use by the Secretary of State in connection with such construction and improvement of highways and the execution of other works mentioned above; and
- (vi) the mitigation of adverse effects which the existence or use of the new trunk road and other highways to be constructed by him as mentioned above will have on their surroundings.

Copies of the Compulsory Purchase Orders and their plans together with copies of the published made Orders mentioned in (i) and (ii) above (with their plans) and the A41 London to Birmingham Trunk Road (East of Aylesbury to West of Tring) Detrunking Order 1991 (Amendment) Order 1996, have been deposited and may be seen at all reasonable hours from 6th March 1997, to 17th April 1997, at the Highways Agency Room, 12/08 St. Christopher House, Southwark Street, London SE1 0TE; at the offices of the Director, Southern Operations Division, Highways Agency, Room 4/14 Tollgate House, Houlton Street, Bristol BS2 9DJ; at the offices of Buckinghamshire; Aylesbury Vale District Council, Exchange Street, and Friars Square, Aylesbury; at the County Library in Aylesbury and the mobile library for Aston Clinton and Buckland; and at the Post Office in Aston Clinton.

The Orders as made become operative on the date when this notice is first published. Any person agrieved by either of the Orders may question its validity on the grounds that:

- (a) the authorisation granted by the Order is not empowered to be granted; or
- (b) his or her interests have been substantially prejudiced by failure to comply with any statutory requirements relating to the Order.
