Application for a licence to abstract water and to vary existing licences

Take notice that F. H. Cookson & Sons, Agden Brook Farm, Lymm Road, Little Bollington, Altrincham, Cheshire WA144TE, are applying to the Environment Agency for a licence to abstract water from the Bridgewater Canal at Agden, Lymm, Cheshire, between National Grid references SJ7025 8740 and SJ7205 8660, for spray irrigation purposes at rates not to exceed 60 metres per hour, 900 metres per day, 13,650 metres per year, and to vary the following licences:
