

## TOWN AND COUNTRY PLANNING ACT 1990

*Stopping-Up of a Highway at Manchester City Centre*

The Secretary of State for Transport hereby gives notice that on the application of Potier & Company, he has made an Order under section 247 of the above Act entitled "The Stopping-Up of Highways (City of Manchester) (No. 2) Order 1997" authorising the stopping-up of a length of Tivoli Street, Manchester, and requiring the provision of a turning head.

## TOWN AND COUNTRY PLANNING ACT 1990
