#### THE HIGHWAYS ACT 1980

*The County Borough of Wrexham (St. Giles Link Classified Road)  
Side Roads Order 1996*

The Secretary of State for Wales hereby gives notice that he has confirmed the above Order which was made by the Wrexham County Borough Council under sections 14, 125 and 326 of the Highways Act 1980, and which, as confirmed, authorises the Council:

- (a) to improve, raise, lower or otherwise alter highways,
- (b) to stop up highways,

- (c) to construct new highways, and
- (d) to stop up private means of access to premises,

all on or in the vicinity of and in relation to a new highway which the Council proposes to construct at Wrexham, in the County Borough of Wrexham, classified as a Principal Road and designed as part of the St. Giles Link Scheme to provide a new classified road link to run from the existing A525 Salop Road, Wrexham, at its junction with Willow Road in a general north-westerly direction for a distance of approximately 380 metres to A5152 Bridge Street at its junction with Brook Street and Town Hill the whole being known generally as the St. Giles Link.

The County Council of Clwyd (Wrexham Inner Ring Road, Salop Road to Bridge Street, Principal Road) Side Roads Order 1988, is hereby revoked.

Copies of the Order, as confirmed, and of the relevant plan may be inspected, free of charge, at all reasonable hours, at the offices of the Chief Transportation and Engineering Officer, Wrexham County Borough Council, Crown Buildings, 31 Chester Street, Wrexham; Wrexham Library, Rhosddu Road, Wrexham; and at the Planning Inspectorate, Crown Buildings, Cathays Park, Cardiff.

Any person aggrieved by the Order, and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of that Act or of any regulation made thereunder has not been complied with may, within 6 weeks of 5th May 1997, apply to the High Court for the suspension or quashing of the Order or any provision contained therein.
