Notice of application for a new licence and to vary an existing licence to abstract water

Take notice that A. Sole & Son, of East Leys, Hundreds Farm, Langwood Fen, Chatteris, Cambridgeshire PE166XF, is applying to the Environment Agency for a licence to abstract water and to vary a licence as follows:

(a) to abstract 130 cubic metres per hour, 3,119 cubic metres per day, and 79,557 cubic metres per year between 1st November and 31st March each year, from a private dyke and the Counter Drain soke dyke at National Grid References TL451854 and TL461847 in the Sutton and Mepal Internal Drainage District at Chatteris parish, Fenland District, Cambridgeshire, to fill a winter storage reservoir at East Leys. Discharge from the reservoir at National Grid Reference TL451853 by underground pipeline both direct to land and to the main drain at National Grid Reference TL448849 to be able to reabstract for summer spray irrigation.

(b) to abstract an equivalent quantity of water at 98 cubic metres per hour, 1,769 cubic metres per day and 79,557 cubic metres per year both from direct underground pipeline and main drains and private dykes within the Sutton and Mepal Internal Drainage District between National Grid References TL440820 and TL440860 and TL460840 all at Fortrey's Hall, Bottom Farm, Coopers Farm and Hundreds Farm, Chatteris parish, Fenland District, Cambridgeshire. The water is for spray irrigation purposes between 1st April and 31st October each year following compensatory discharges into drains and dykes from the reservoir at National Grid Reference TL451853.

(c) to vary licence of right serial number 6/33/52/14/13 to abstract water from drains and watercourses in Sutton and Mepal Internal Drainage District at Fortreys Hall and Bottom Farm between National Grid References TL440820 and TL440840 and TL450840, all at Chatteris parish, Fenland District, Cambridgeshire.

The variation proposed is to add additional land and include abstraction points with no increase in quantities at Coopers Farm and Hundreds Farm between National Grid References TL440840 and TL440860 and TL460840, all at Chatteris parish, Fenland District, Cambridgeshire.

## ROAD TRAFFIC ACTS

#### CITY OF LONDON

Installation of a Bus Lane in Mansell Street/Aldgate High Street

Notice is hereby given that the Common Council of the City of London on 1st May 1997, made the City of London (Bus Lane) (No. 1) Order 1997, and the City of London (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 11) Order 1997, under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

Notice of the Common Council's intention to make the Orders was first given in *The London Gazette* on 28th May 1996, pages 7316-7, Ref. 492 and the effect of the Orders will be the same as given in that notice.

The effect of the bus lane Order will be to prohibit any vehicle from entering or proceeding in the area of carriageweay (known as "the bus lane") lying within or adjacent to the lengths of Mansell Street and Aldgate High Street, specified in the Schedule to this notice, and between the south-western and south-eastern edge of the carriageway and a longitudinal single white line marked on the carriageway of those lengths of roads between 7 a.m and 7 p.m., on Mondays to Fridays inclusive.

The prohibition will not apply, in relation to:

- (a) a local bus as defined in the Traffic Signs Regulations and General Directions 1994;
- (b) a vehicle being used for ambulance, fire brigade or police purposes in an emergency;
- (c) a pedal cycle;
- (d) a licensed cab;
- (e) any vehicle being used in connection with the removal of any obstruction in the bus lane;
- (f) a vehicle being used in the service of a local authority for the purpose of cleansing or for the purpose of collecting refuse from premises adjacent to the bus lane, in connection with the improvement or reconstruction of the highway in or adjacent to the bus lane, the laying, erection, alteration or repair in or adjacent to the bus lane of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system, or the placing, maintenance or removal of any traffic sign, provided that in all the circumstances it is reasonably necessary for the vehicle to enter the bus lane:
