The Stopping-up of Highways (Old Port Road, Wenvoe, Vale of Glamorgan) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 248 of the Town and Country Planning Act 1990 to authorise the stopping-up of the length of highway described in the Schedule to this notice.

If the Order is made, the stopping-up will be authorised only in order to enable road realignment to be carried out in accordance with planning permission granted by Vale of Glamorgan Council on 23rd May 1996 under Ref. 96/00250/FUL. The proposed Order shall cease to have effect upon the cessation of the planning permission.

In the preparation of an objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
