TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of areas of highway at Londonderry Avenue, Haig Crescent and Hilda Avenue, Sherburn Road Estate, Durham.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Anthony Watson, Chartered Architect, acting as agents for Leech Homes, by City of Durham, on 4th September 1996, under Ref. FPA/P/4/96/0429.

Copies of the draft Order and relevant plan may be inspected, at all reasonable hours, during 28 days commencing on 12th May 1997, at the offices of the Council of the City of Durham, Technical Services Department, Ruth First House, Durham DH1 1XE, and may be obtained, free of charge, from the Department of Transport, quoting Ref. GONE 97/5035/35/01, at the address stated below.

Any person may object to the making of the proposed Order within the period of 28 days commencing on 12th May 1997, by notice to the Secretary of State for Transport, quoting the above reference, at the office of the Director Planning, Environment and Transport, Government Office for the North East, Wellbar House, Gallowgate, Newcastle upon Tyne NE1 4TD.

In preparing an objection, it should be borne in mind that the substance of it may be imparted to other persons who may be affected by it and that those persons may wish to communicate with the objector about it.

The Minister of Agriculture, Fisheries and Food, and the Secretary of State for Scotland and the Secretary of State for Wales, acting jointly, in exercise of the powers conferred on them by sections 1, 7(1), 8(1), 14(1), 15(4) 23, 25, 28, 83(2) of the Animal Health Act 1981(a), and of all other powers enabling them in the behalf, hereby make the following Order:

S.I. 1997 No. 968

This Order may be cited as the Sheep Scab Order 1997, and shall come into force on 1st July 1997.

This Order gives a local authority power to serve a notice requiring the temporary clearance from common land of sheep affected with sheep scab (articles 3 and 4). If sheep are not moved in accordance with the notice the local authority may seize them (article 5).

The Order prohibits the movement of sheep affected with sheep scab from any premises other than in accordance with this Order or in other specified circumstances (article 6). It requires a keeper of sheep affected with sheep scab to treat the animal and all other sheep in the flock, and gives to local authorities powers to serve notices requiring treatment, and default powers if the notice is not complied with (articles 7 and 8). It enables a veterinary inspector to take samples relating to sheep scab (article 9) and enables an inspector to mark the sheep (article 10). It is enforced by the local authority (article 11).

Breach of this Order is an offence under section 73 of the Animal Health Act 1981.
