(2) Limit waiting, 8 a.m. to 6 p.m. daily, to 20 minutes, return prohibited within 40 minutes, on the east side of Princess Street, from a point 10.5 metres north of the centre line of Silk Mill Street to a point 35.5 metres north of the centre line of Silk Mill Street.
