Notice of application to vary a licence to abstract water

Take notice that Humax (UK) Limited, of Lamerwood Country Club, Codicote Road, Wheathampstead, Hertfordshire AL4 8RH, is applying to the Environment Agency to vary licence serial number WRL/38/1/86 to abstract water from Lamerwood Country Club (Borehole), Codicote Road, Wheathampstead, Hertfordshire AL4 8RH, at National Grid Reference TL184151 at Lamerwood Country Club, Codicote Road, Wheathampstead, Hertfordshire AL4 8RH.

The variation being applied for is an increase in spray irrigation of the golf course from the presently-authorized yearly maximum 20,457 cubic metres to 25,000 cubic metres and the change of period of irrigation from 1st April to 30th November to 1st March to 31st October in each year and to allow use of abstracted water in the club house all the year round to a maximum yearly quantity of 7,500 cubic metres.

Take notice that Dŵr Cymru Welsh Water, of Plas y Ffynnon, Cambrian Way, Brecon, Powys, is applying to the Environment Agency for a licence to abstract water from Afon Dilyn, at Tal-y-Bont, at National Grid Reference SH76316891, in the community of Caerhun, in the borough of Conwy.

The proposal is to abstract water at the following rates: 36 cubic metres per hour, 864 cubic metres per day, 316,000 cubic metres per year.

The purpose of the application is to allow water to be transferred from Afon Dilyn to augment the flow of Afon Bach. The transfer would take place on a permanent basis, subject to sufficient flows in the Afon Dilyn.

Notice of substantial road works
