

- (iii) (on event days only) prohibit waiting, Monday to Friday, 5.30 p.m. to 10 p.m., Saturday to Sunday, 12 noon to 7 p.m., in the streets in the attached Schedule.

The prohibitions referred to in the above paragraph do not apply in respect of anything done with the permission or at the direction of a Police Constable in uniform or in certain circumstances, e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol from road side petrol stations; to licenced street traders etc. The usual exemption relating to vehicles displaying a disabled persons' "Orange Badge" does apply.
