- (b) that his interests have been substantially prejudiced by failure to comply with any statutory requirement relating to the Order.

THE HIGHWAYS ACT 1980

The A14 Trunk Road (Levington to Trimley St. Martin Improvements Side Roads) Order 1997

Notice is hereby given that the Secretary of State for Transport has made an Order under sections 14 and 125 of the Highways Act 1980, in relation to the A14 Trunk Road at Trimley St. Martin in the District of Suffolk Coastal and the County of Suffolk, which will:

- (1) authorise him to:
 - (a) improve highways,
 - (b) stop up highways,
 - (c) construct new highways,
 - (d) stop up private means of access to premises, and
 - (e) provide new private means of access to premises.

all at Trimley St. Martin in the said District and County; and

- (2) provide for the transfer of each new highway to the highway authority specified for it in the Order as from the date on which he notifies them that it has been completed and is open for traffic.

may apply to the High Court within 6 weeks from the date of first publication of this notice. On such an application, the Court may suspend or quash the Order or any provision in it.

ROAD TRAFFIC REGULATION ACT 1984

The A14 Trunk Road (Levington to Trimley St. Martin Improvements) (Prohibition of Left Turn and Closure of Gaps in Central Reservation) Order 1997.

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984.

The effect of the Order is to close the gaps in the central reservation of the trunk road opposite its junctions with:

- (i) the U3219,
- (ii) Croft Lane C375,
- (iii) Morston Hall Road U3115 and
- (iv) Walkbarn Lane U3214;

and to prevent any vehicle travelling westwards in the trunk road to turn left into the U3214.

The Order also revokes the following Orders:

The A14 Trunk Road (Levington to Trimley St. Martin, Suffolk) (Closure of Gaps in the Central Reservation) (Experimental) Order 1995.

(Suffolk County Council) (Parish of Trimley St. Martin) (A1093) (Prohibition of Right Hand Turn) Order 1983,

The Trunk Road (Trimley St. Martin) (A45) (Prohibition of Right Turn) Order 1983, and

The Trunk Road (A45) (Felixstowe-Weedon) (Temporary No U Turn at the Morston Hall Road Junction, Trimley St. Martin) Order 1983.

Any person who wishes to question the validity of, or of any provision contained in the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any Instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 4th July 1997, apply to the High Court for the suspension or quashing of the Order of any provision contained in it.
