#### *Notice of application to vary a licence to abstract water*

Take notice that Mark Sizer and Sons, of 1 Thorn Close, Soham, Ely, Cambridgeshire CB7 5EH, are applying to The Environment Agency to vary licence serial number 6/33/40/S/59 (incorporating No. 6/33/46/S/135) to abstract water from drains in the areas of the Burnt Fen and the Southery & District Internal Drainage Board, at National Grid Reference TL 6292 8567 and TL 6777 8620 at Littleport, Cambridgeshire and Hockwold, Norfolk.

The variations proposed are as follows:

- (1) To increase the rates at which water may be abstracted at National Grid Reference TL 6292 8567 (Littleport), from 45.4 to 91 cubic metres per hour and from 909.2 to 1,818 cubic metres per day.
- (2) To abstract 45.4 cubic metres per hour, 909.2 cubic metres per day and 12,000 cubic metres per year, from a drain in the area of Burnt Fen Internal Drainage Board from National Grid Reference TL 6768 8388 thro TL 6809 8391 to TL 6814 8372, for spray irrigation at Lakenheath, Suffolk. These quantities are to be aggregated with the existing licence quantities, so there is no overall increase.
