WATER INDUSTRY ACT 1991, SECTION 19(1)(b)

Consumers supplied by North West Water Limited in parts of Tameside, Trafford, Eden, South Lakeland, Lancaster, Congleton, Chester, Rochdale, Oldham and Macclesfield might be affected by improvement work being carried out in these areas.

The following briefly explains the content of the legal notice below.

Water supplied to consumers in the above areas sometimes does not always meet the drinking water quality standard for lead due to its presence in the pipework. These failures to meet the standard do not make the water unsafe to drink at any time

The Drinking Water Inspectorate (DWI) acting for the Secretary of State has required the Company to take action to improve the quality of the supply to consumers by 31st March 1998
