install, commission and operate phosphate dosing equipment at Godley Treatment Works to effectively treat the water supplied, so that the prescribed risk is minimised or eliminated. To be completed by 31st December 1997.

(II) For Swindale, Haweswater, Sedburgh, Haweswater/Lune, Dolphinholme, Cloud. Congleton Congleton Mow Cop, Malpas, Ashworth Moor, Bamford East, Watergrove, Westwood, Millbrook and Ridgegate Water Supply Zones:

1. Investigate which of the following methods will minimise lead concentrations in water supplied to consumers:

(i) further pH control;

(ii) increased alkalinity;

- (iii) phosphate dosing; or (iv) lead pipe replacement.
- Completed by 31st July 1997.

2. In the light of step (1), secure Company approval for the preferred method for each zone. To be completed by 30th September 1997.

3. Complete the preferred method for each zone. To be completed by 31st March 1998.

(III) Report progress on all of the above steps to the Drinking Water Inspectorate at two monthly intervals. First report to be with DWI by 31st July 1997 and subsequent reports every two calender months thereafter, for the duration of the undertaking.

4. is satisfied that North West Water Limited has given and is complying with an undertaking to take all such steps as appear to the Secretary of State for the time being to be appropriate to secure or facilitate compliance with the requirement of Regulation 3(3)(c) of the Water Supply (Water Quality) Regulations 1989.
