Demolition of existing multi-storey block of flats, and erection of 54 new accommodation units comprising 42 two/three storey houses, 2 three storey flat blocks, extension of Southport Road and associate landscaping, parking and retaining walls. (570)

TOWN AND COUNTRY PLANNING ACT 1990
