Brislington, City of Bristol) (South Eastern Zone) (One Way Traffic and Cycle Lane) Order 1997 under sections 1(1), 2(1) to (3), 4(1) of and Part IV of Schedule 9 to the said Act, the effect of which is:

(a) to prohibit all vehicles other than pedal cycles from entering, proceeding or waiting in that length of the south-east side of Glenarm Road, Brislington, which extends from 20 metres north-east of its junction with the A4 Brislington Hill to the said junction. Pedal cycles will travel in a south-westerly direction (i.e. towards A4 Brislington Hill);

(b) to institute one-way traffic working in that length of Glenarm Road, Brislington, in the area of carriageway north-west of the

cycle lane specified in item (a) above, in a north-easterly direction (i.e. towards Glenarm Walk); and (c) to revoke the "no waiting at any time" restriction that exists on the south-east side of Glenarm Road which extends from its junction with the A4 Brislington Hill for a distance of 15 metres in a north-easterly direction by virtue of the City Council of Bristol (A4 Brislington Hill and Glenarm Road, Brislington, City of Bristol) (South Eastern Zone) (Prohibition and Restriction of Waiting) Order 1997—this restriction is superseded by the provisions referred to in item (a) above.

Item (a) only—Exemptions are provided for any vehicle:

(i) to enter, proceed in any direction or wait in the cycle lane

for emergency purposes, and

(b) to enter, proceed in a north-easterly direction or wait in the cycle lane for the avoidance of an accident, access to or egress from off-street loading or garaging accessible only from the cycle lane; the pursuance of statutory powers or duties; in connection with the supply of gas, water or electricity or of any apparatus as telecommunication defined Telecommunications Act 1984; the overtaking of a stationary vehicle situated in the area of carriageway north-west of the

The above Orders make permanent the provisions currently in operation of the City Council of Bristol (A4 Brislington Hill/Glenarm Road, Brislington, City of Bristol) (South Eastern Zone) (Prohibition of Right Turn) Experimental Order 1996 and the City Council of Bristol (Glenarm Road, Brislington, City of Bristol) (South Eastern Zone) (One Way Traffic and Cycle Lane) Experimental Order 1996 respectively, which they revoke.
