(ii) the Enfield (Waiting and Loading Restriction) (Special

Parking Area) (Amendment No. 86) Order 1997; (iii) the Enfield (Restriction of Waiting on Bus Stops) (Special Parking Area) (No. 1, 1997) (Amendment No. 3) Traffic Order 1997;

(iv) the Enfield (Free Parking Places) (Special Parking Area) (No. 9) Order 1997;

under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

2. The general effect of Short Term Parking Places Order will be to:

- (a) revoke the designation by:
 - (i) the Enfield (Free Parking Places) (Upper Edmonton) (Special Parking Area) (No. 1) Order 1996 of the parking places situated in Fore Street;
 - (ii) the Enfield (Short Term Parking Places) (Various Roads) (Lower Edmonton) (Special Parking Area) (No. 1) Order 1997 of the parking place designated in Fore Street;
- (b) designate free parking places in:
 - (i) the lengths of Bridge Road, Church Street, Edmonton, Denny Road, Fore Street, Grove Street, Henderson Road, Hertford Road, Edmonton, New Road, North Road and the service road fronting Nos. 205 to 239 Fore Street specified in Schedule I to this notice, in which vehicles authorised by the Order may be left for a period of 2 hours without charge between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
 - (ii) the lengths of Fore Street specified in Schedule 2 to this notice, in which vehicles authorised by the Order may be left for a period of 2 hours without charge between 10 a.m. and 6.30 p.m. on Mondays to Fridays inclusive and between 7 a.m. and 6.30 p.m. on Saturday (Christmas Day, Good Friday and Bank Holidays excepted);
 - (iii) the lengths of Alpha Road N.18, Cowper Road and Fore Street specified in Schedule 3 to this notice, in which vehicles authorised by the Order may be left for a period of 2 hours without charge between 8 a.m. and 7 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);

- (e) provide that certain other vehicles may wait in the parking places in certain circumstances.
- 3. The general effect of the Waiting and Loading Restriction Order will be further to amend the Enfield (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that:
 - (a) the existing restrictions on waiting by vehicles, on the sale of goods and on advertising activities imposed by the above-mentioned Order of 1994 in the lengths of streets specified in Schedule 5 to this notice will be revoked;

 - B) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive, in the length of street specified in Schedule 10 to this notice;
 - (ii) unless, prohibited as above, for a period of more than 20 minutes in the same place will be prohibited:
 - (A) between 11 a.m. and 6.30 p.m. throughout the week in the lengths of streets referred to in sub-paragraph (b)(i) above;

 - (d) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraph (b) above will be prohibited except on a Sunday, unless there is in force a valid licence issued by Enfield Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
 - (e) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the lengths of streets referred to in sub-paragraph (b) above, will be prohibited;
 - (f) the hours during which the existing prohibition on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that it will apply:
