The A13 Trunk Road (A117 Junction Improvement) Compulsory Purchase Order (No. PS 1) 1997

Notice is hereby given that the Secretary of State for Transport in exercise of the powers conferred on him by the above-mentioned Acts, on 14th October 1997 made a Compulsory Purchase Order, entitled as above, which provides for the purchases of the land and rights described in the Schedule to this notice for the purposes of:

- the construction of the A13 Trunk Road at Beckton and East Ham, in the London Borough of Newham, in pursuance of the A13 Trunk Road (A117 Junction Improvement, Trunk Road and Slip Roads) Order 1996;
- the construction and improvement of highways and the provision of new means of access to premises at Beckton and East Ham in the said Borough, in pursuance of the A13 Trunk Road (A117 Junction Improvement, Side Roads) Order 1996;
- the improvement of the trunk road at Beckton and East Ham in the said Borough;
- use by the Secretary of State in connection with such construction and improvement of highways, and the execution of other works mentioned above.

The Order as made, became operative on the date on which this notice is first published, but a person aggrieved by the Order may, by application to the High Court within 6 weeks from that date, question its validity on the grounds that the authorisation granted by the Orders is not empowered to be granted, or that there has been a failure to comply with any statutory requirement relating to the Orders.

(a) The land comprised in each item in this Schedule is identified on the plan referred to in the made Compulsory Purchase Order by means of the number or numbers shown in brackets against that item in this Schedule.

(b) References to ownership are references to ownership or reputed ownership at the time of preparation of the made Compulsory Purchase Order and are stated for the purpose of identification of the land.

In the London Borough of Newham

Part of grassed open space known as Beckton District Park, on the south of the A13 (Newham Way), Beckton E.6, and on the west of East Ham Industrial Estate (1). Parts of front yard and entrance to East Ham Industrial Estate, including fences, trees, kerbs, paved car parking area, paved entrance way, on the south of the A13 (Newham Way), E.6 (2, 2A and 2C). The right to enter upon part of front yard of East Ham Industrial Estate, including kerb and paved car parking area, on the south of the A13 (Newham Way), Beckton E.6, for all

The East Ham Manor Way Transmission Substation and site, including fences, gates, steps, paths and embankments (5B). Parts of the Beckton Sports Ground, including fence and gates, on the west of the A117 (Woolwich Manor Way), Beckton E.6, and on the north of the Golf Driving Range, (5C, 5D and 5E). Part of the road embankment, including fence and trees, on the west of the A117 (Woolwich Manor Way), Beckton E.6, and on the north of the Golf Driving Range (5F). Half widths of the A13 (Newham Way), adjoining 1173 and 1181 Newham Way, East Ham E.6 (6 and 8). Half widths of the A13 (Newham Way), adjoining 1175 and 1177 Newham Way, East Ham E.6 (7) (in unknown ownership). Half widths of the A13 (Newham Way) adjoining 13, 11, 9, 7, 5, 3, 1 and 1A Roman Road, East Ham E.6 (9, 10, 11, 12, 13, 14 and 15). Part half widths of carriageway of the A13 (Newham Way), together with adjoining part half widths of Roman Road and A117 (Woolwich Manor Way), East Ham E.6 (16). Parts of grassed area including fence and embankment, on the north of Roman Road and on the west of the A117 (High Street South), East Ham E.6 (17 and 17A). Parts of the Northern Outfall Sewer, including grassed areas, fences, embankments, gates, paved area, public telephone booth and paths, on the north of Roman Road, on the west of the A117 (High Street South), East Ham E.6, and on the south of Lonsdale Avenue (18, 18A, 18B, 18C and 18D). Parts of Transmission Substation site, including fences, access, driveway, gate and grassed area, on the south of Lonsdale Avenue and on the west of the A117 (High Street South), East Ham E.6 (19, 19A and 19B). Parts of grassed area, including fences and trees, on the south of Lonsdale Avenue and on the west of the A117 (High Street South), East Ham E.6 (20 and 20A). Parts of grassed area at the foot of Beckton Alps, Beckton, including access path and bushes, on the east of the A117 (Woolwich Manor Way), East Ham E.6, on the south of the A13 (Newham Way), and on the west of the Northern Outfall Sewer (21 and 21A). Half width of the A13 (Newham Way), East Ham E.6, on the east of St. Mary Magdalene Churchyard and on the west of Masefield Gardens (25) (unknown ownership). Part of rough grassed area, including landscaped environmental bunds, embankments, fences, drainage ditches, grazing pasture, gates and track to the East Ham Terminal Point Transmission Substation on the south of the A13 (Newham Way) and on the north of the Northern Outfall Sewer, Beckton, together with adjoining part half width of the A13 (Newham Way) and width of Gooseley Lane, Beckton E.6 (26). Part of rough grassed area, including landscaped environmental bunds, fences, supermarket sign and flag poles, on the south of the A13 (Newham Way), Beckton E.6 (29 and 29A).
