Notice of application for a licence to abstract water

Take notice that J. Norton and Sons of Church Farm, Frettenham, Norfolk, are applying to the Environment Agency for a licence to abstract water from underground strata (CHALK), at National Grid Reference TG 2393 1865, at Frettenham, Norfolk.

The proposal is to abstract water at the following rates: 50 cubic metres per hour, 1,000 cubic metres per day and 58,000 cubic metres a year between the months of April and October inclusive. The water will be used for spray irrigation. This application is to replace without change in the annual abstraction the abstraction authorised by licence number 7/34/6/G/216 which expires on 31st October 1998.

J. Norton and Sons are also applying to the Environment Agency for a licence to abstract water from underground strata (CHALK) within fifty metres of National Grid Reference TG 2423 1828. The proposal is to abstract water at the following rates: 50 cubic metres per hour, 1,000 cubic metres per day and 58,000 cubic metres per year between the months of April and October inclusive provided that the aggregate quantity of water from both of these above-mentioned sources does not exceed 50 cubic metres per hour, 1,000 cubic metres per day and 58,000 cubic metres per year. The water will be used for spray irrigation.

Notice of applications for licences to abstract water

Take notice that Allan Partners, of Kings Farm, Langwood Fen, Chatteris, Cambridgeshire, is applying to the Environment Agency for licences to abstract water in the area of Sutton & Mepal IDB.

The first licence is the renewal of their existing licence to be abstracted from the dykes at Kings & Hundreds Farms, Langwood Fen, Chatteris, Cambridge.

The proposal is to abstract at the following rates: 87.1 cubic metres per hour, 1,745.5 cubic metres per day, 81,800 cubic metres per year (between 1st April and 31st September each year), for spray irrigation.

The second application is for a licence to abstract water from Sutton & Mepal IDB drains at National Grid References TL 4566 8590 and TL 4546 8560, at Langwood Fen, Chatteris, Cambridge.

The proposal is to abstract water at the following rates: 108 cubic metres per hour, 2,600 cubic metres per day, 77,283 cubic metres per year (1st November and 28th February each year), to fill a reservoir for winter storage and subsequent spray irrigation.
