### TOWN AND COUNTRY PLANNING ACT 1990

*The Extinguishment of Public Rights of Way (Wentloog Road and Trowbridge Road, Wentloog, Cardiff) Order 1997*

The Secretary of State for Wales hereby gives notice that he has made an Order under section 251 of the Town and Country Planning Act 1990, to authorise the extinguishment of public rights of way over the lengths of highway described in the Schedule to this notice.

The extinguishment is authorised only in order to enable development consisting of the construction of electronics manufacturing plant to be carried out on land appropriated for planning purposes by the County Council of the City and County of Cardiff.

The Order requires the provision of a new public right of way which will be a highway maintainable at public expense, for which the County Council of the City and County of Cardiff shall be the Highway Authority.

If any person desires to question the validity of the Order, or of any of the provisions contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990; or
- (b) that their interests have been substantially prejudiced by a failure to comply with any of the requirements of the Act,
