The following notice is in substitution for that which appeared on page 13413 of The London Gazette dated 28th November 1997:

HARBOURS ACT 1964

Proposed Great Yarmouth Outer Harbour Revision Order

Notice is hereby given that Great Yarmouth Port Authority ("the Authority") has applied to the Secretary of State for Transport to make a Harbour Revision Order under section 14 of the Harbours Act 1964.

The objects of the proposed Order are:

- to provide that the powers of the Great Yarmouth Outer Harbour Act 1986, for the compulsory acquisition of land required for works authorised by that Act ("the Outer Harbour project") may be exercised until 31st December 2000 or 31st December 2005, depending on the work;
- to modify the 1986 Act to provide that development authorised by the Act and begun before 8th November 2006, is permitted development; and
- to empower the Authority when it is ready to commence so much of the Outer Harbour project as requires the closure of the esplanade, to stop up permanently and extinguish rights of way (if any), over that part of the esplanade as is shown on the plan deposited with the Order.

The Secretary of State has determined that the Outer Harbour project falls within Annex I to Council Directive 85/337/EEC and thus is subject to environmental assessment.

A copy of the draft Order which accompanied the application, the plan relating thereto, the book of reference describing the lands subject to compulsory purchase under the 1986 Act and the environmental statement with its non-technical summary, may be seen at all reasonable hours at the offices of the Authority at 20-21 South Quay, Great Yarmouth, Norfolk NR30 2RE.

Any person desiring to make an objection to the Secretary of State against the application should write to Mr. K. M. Notice of application for a licence to obstruct or impede the flow of an inland water by means of impounding works

Take notice that Stickells, (t/a Ware Farms), of Great Ware Farm, Ash, Canterbury, Kent CT3 2NA, are applying to the Environment Agency for a licence to impede the flow of the Ware Lead Dyke at National Grid Reference TR 282 604 at Ware.

The water will be impounded by means of an earth dam with a low level by-pass pipe. The object of the impounding works is to retain a body of water up-stream of the currently licenced abstraction point. No additional licenced quantity is being sought and the by-pass pipe will allow the summer flow to pass unimpeded.

Take notice that Gosfield Lake Golf Club Ltd., of The Manor House, Gosfield, Halstead, Essex, is applying to the Environment Agency to vary licence serial numbers 8/37/22/S/26 and 8/37/22/G/32 which authorise the abstraction of water from Gosfield Lake at National Grid Reference TL 772 294 and a borehole into Kesgrave sand and gravel at National Grid Reference TL 771 299, both at Gosfield Lake Golf Club.

The variation being applied for is to amend the daily rate of abstraction to 100 cubic metres (from 62 cubic metres), in order to obtain the full authorised aggregated annual licence quantity of 15,910 cubic metres during the period April to October. No proposed increase in authorised rate of abstraction in litres per second.

WATER RESOURCES ACT 1991, SCHEDULE 10 AS AMENDED BY THE ENVIRONMENT ACT 1995

Notice of application for consent for the purposes of section 88

Notice is hereby given in accordance with Schedule 10 of the above Act that an application has been made to the Environment Agency by Severn Trent Water Limited for consent to discharge the following effluents to the Piddle Brook, at OS National Grid Reference SO 9828 5596, from Kington Sewage Treatment Works, The Bourne, near Kington, Worcestershire:

- up to 173 cubic metres per day of Secondary Treated Sewage Effluent (31 cubic metres per day under dry weather flow conditions);
- a rainfall dependent volume of settled storm sewage for flows in excess of 2 litres per second and only at times when a storm tank capacity of 20 cubic metres has been fully utilised;
- sewage in an emergency from the sewage pumping station at the works' inlet and only at times when the storm tank capacity of 20 cubic metres has been fully utilised. The pumping station will be provided with the following:
 - a duty and standby pump;
 - telemetric alarms for pump and treatment plant failure, high level alarm on wet well and intruder alarms;
