Farnborough Avenue:

- (a) the north-east side, between the north-western kerb-line of Selsdon Park Road and a point 3 metres south-east of the boundary wall of Nos. 2 and 3 Farnborough Avenue;
- (b) the south-west side:
 - (i) between the north-western kerb-line of Selsdon Park Road and a point 37.50 metres south-east of a point opposite the party wall of Nos. 2 and 3 Farnborough Avenue;
 - (ii) between the junction with Farnborough Crescent and a point 6 metres south-east of a point opposite the party wall of Nos. 10 and 11 Farnborough Avenue.

Farnborough Crescent:

- (a) between the north-western kerb-line of Selsdon Park Road and a point 42.50 metres south-east of the party wall of Nos. 27 and 28 Farnborough Crescent;
- (b) the west and north-west side, between the junction with Farnborough Avenue and a point 7 metres north-east of a point opposite the party wall of Nos. 53 and 54 Farnborough Crescent.

Selsdon Park Road:

the north-west side:

- (i) between a point 4 metres north-east of the party wall of Nos. 71 and 73 Selsdon Park Road to a point 6 metres south-west of the party wall of Nos. 75 and 77 Selsdon Park Road;
- (ii) between a point 15 metres north-east of the party wall of Nos. 99 and 101 Selsdon Park Road.

Notice is hereby given that the Council of the London Borough of Enfield, on 1st December 1997 made:

- (a) the Enfield (Residents' Parking Places) (Arnos Grove) (Special Parking Area) (No. 2) Order 1997;
- (b) the Enfield (Business Parking Places) (Arnos Grove) (Special Parking Area) (No. 2) Order 1997;
- (c) the Enfield (Free Parking Places) (Special Parking Area) (No. 10) Order 1997;
- (d) the Enfield (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 91) Order 1997;

under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

2. The general effect of the Residents' Parking Places Order (Arnos Grove) will be to:

- (a) revoke the designation by the Enfield (Residents' Parking Places) (Arnos Grove) (Special Parking Area) (No. 1) Order 1997, of the residents' parking places numbered 8, 26, 34, 70, 71, 120, 122, 124 and 127 therein situated in Betstyle Road, Brookdale, Palmers Road, Ravenscraig Road, the access road leading to the rear of Nos. 120 to 130 Palmers Road, the access road leading to the rear of Nos. 132 to 142 Palmers Road, the access road leading to the rear of Nos. 66 to 96 Palmers Road and the service road at the rear of Nos. 392 to 412 Bowes Road;
- (b) designate residents' parking places in Betstyle Road, Brookdale, Seafeld Road, the access road leading to the rear of Nos. 120 to 130 Palmers Road, the access road leading to the rear of Nos. 132 to 142 Palmers Road, the access road leading to the rear of Nos. 66 to 96 Palmers Road and the service road at the rear of Nos. 392 to 412 Bowes Road at which charges may be made by the Council for vehicles authorised by the Order to be left in those parking places;
- (c) provide that the parking places will operate between 11 a.m. and 12 noon on Mondays to Fridays inclusive, (Christmas Day, Good Fridays and Bank Holidays excepted);

(d) specify that the vehicles which may be left in the residents' parking places shall be those displaying a valid residents' permit, a valid community health staff permit, a valid social services staff permit, a valid carers' permit, a valid special permit or a valid residents' visitor parking card issued by the Borough Council or its authorised agent under the provisions of the Enfield (Residents' Parking Places) (Arnos Grove) (Special Parking Area) (No. 1) Order 1997;

- (e) provide that the charge for the issue of a residents' permit will be £10 and which will be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (f) provide that the charge for the issue of a community health staff permit or a social services staff permit will be £5 and which will be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (g) provide that the charge for the issue of a special permit or a carers' permit will be £20 and which will be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (h) provide that the charge for the issue of residents' visitor parking cards which, upon validation, will be valid for a single period between 11 a.m. and 12 noon on any day on Mondays to Fridays inclusive, will be 20 pence each. These parking cards will be available in booklets comprising 10 parking cards each (a maximum of 50 parking cards may be issued to a householder in a 12 month period);
- (i) provide that certain vehicles may wait, free of charge, in certain circumstances, e.g. to allow persons to board or alight (maximum two minutes), to load or unload (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit).

3. The general effect of the Business Parking Places Order will be to:

- (a) designate business parking places in Palmers Road, Ravenscraig Road and Springfield Road at which charges may be made by the Council for vehicles authorised by the Order to be left in those parking places;
- (b) specify that the vehicles which may be left in the business parking places shall be those displaying a valid business permit issued by the Borough Council or its authorised agent under the provisions of the Enfield (Business Parking Places) (Arnos Grove) (Special Parking Area) (No. 1) Order 1997;
- (c) provide that the charge for the issue of a business permit will be £15 and which will be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (d) contain similar provisions to those set out in paragraphs 2(c) and 2(i) above.

4. The general effect of the Free Parking Places Order will be to:

- (a) revoke the designation by the Enfield (Free Parking Places) (Special Parking Area) (No. 2) Order 1997, of the free parking places numbered 208 and 219 therein situated in Betstyle Road and Lombard Road;
- (b) designate free parking places (no time limit) in lengths of Betstyle Road, Cross Road N.11, and Lombard Road at which vehicles authorised by the Order may be left for any period without charge;
- (c) provide that the parking places will be in operation between 11 a.m. and 12 noon on Mondays to Fridays inclusive, (Christmas Day, Good Friday and Bank Holidays excepted);
- (d) specify, that in respect of the parking places, that passenger vehicles (12 seats or less), good carrying vehicles, motor cycles or invalid carriages may be left therein;
- (e) provide that certain other vehicles may wait in the parking places in certain circumstances.

5. The general effect of the Waiting and Loading Restriction Order will be further to amend the Enfield (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 11 a.m. and 12 noon on Mondays to Fridays inclusive, in the access road specified in the Schedule to this notice;
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11 a.m. and 12 noon on Mondays to Saturdays inclusive, in the street referred to in sub-paragraph (a) above;
- (c) the sale or offer for sale of goods from a vehicle in the street referred to in sub-paragraph (a) above will be prohibited, except on Sunday, unless there is in force a valid licence issued by
