TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Park Street and Regent Street, Bangor Gwynedd) Order 199

Description of the Lengths of Highway to be Stopped-up under this Order

The highways to be stopped-up are at Bangor in the county of Gwynedd. They are shown by zebra hatching on the deposited plan and are:

 (a) the unclassified highway including footway known as Park Street in its entirety from its junction with Deiniol Street to its junction with Penrallt Road;

(b) the unclassified highway including footway known as Regent Street in its entirety from its junction with Deiniol Street to its junction with Penrallt Road.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of a length of Connaught Road, and a length of the un-named footpath linking Connaught Road with Leyes Road, London E.16.
