*The Conversion of Highways into Footpaths or Bridleways (Cardiff City Council) (No. 1) Order 1979 (Revocation) Order 199*

*Notice of the Issue of a Submarine Pipe-line Works Authorisation*

*The City of Newcastle upon Tyne (Crescent Farm, Throckley) (Footpaths) Temporary Diversion Order 199*

*Notice of Public Path Order*

Notice is hereby given that the Secretary of State for the Environment, Transport and the Regions, in exercise of the powers conferred on him by sections 247, 253 and 261 of the Town and Country Planning Act 1990, and all other powers enabling him in that behalf, proposes to make a temporary footpath diversion Order if planning permission is granted by him for the extraction of minerals by surface working.

3. The entire length of Woolsington Footpath No. 8, from its junction with Heddon-on-the-Wall Footpath No. 19 at the footbridge over the drainage ditch, in a generally south-easterly direction for a distance of 306 metres, to its junction with Newburn Footpath No. 32.

The lines and situation of the existing and proposed alternative highways are shown on the map annexed to the Order.
