TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-Up of Highways (Bute Crescent, Bute Street and Stuart Street, Butetown, Cardiff) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the lengths of highway described in Schedule 1 to this notice.

Description of the lengths of highway to be stopped up under the

Order

The highways to be stopped up are at Butetown, Cardiff and comprise:

- (i) an irregular shaped area of the footway and carriageway of Bute Crescent which commences from a point 25 metres south of the boundary between 9 and 10 Bute Crescent and ends 10 metres south of that point, a total area of 210 metres which has a maximum length of 10 metres and a maximum width of 24 metres;
- (ii) a 92 metre length, 5 metres in width of the western footway and the carriageway of Bute Street which commences from a point 20 metres south of the southern facade of The Packet Public House and ends at a point adjacent to the northern boundary of Stuart Street; and

- (ii) a new turning head on the eastern side of Bute Crescent which has a total area of 98 square metres and dimensions of 9.3 metres by 10 metres.

The variation will:

Increase the maximum quantities authorised to be abstracted from 70,000 cubic metres per day to 125,000 cubic metres per day and from 20,075,000 cubic metres per annum to 32,850,000 cubic metres per annum.

Restrict the aggregate quantities authorised to be abstracted from the River Derwent at Little Eaton (under licence 3/28/46/007), from the River Derwent at Little Eaton and Draycott (under licence 3/28/44/006), and from the River Trent at Shardlow (under licence 3/28/36/173), to a maximum of 254,000 cubic metres per day and 79,935,000 cubic metres per annum. There will be no change to any other conditions.

(ii) Licence Number 3/28/44/006 authorises abstraction from the River Derwent at SK 3594 4076 (Little Eaton) and Sk 4451 3270 (Draycott), for treatment for public water supply at Church Wilne Water Treatment Works, Derbyshire.

The variation will restrict the aggregate quantities authorised to be abstracted from the River Derwent at Little Eaton (uinder licence 3/28/46/07), from the River Derwent at Little Eaton and Draycott (under licence 3/28/44/006), and from the River Trent at Shardlow (under licence 3/28/36/173), to a maximum of 254,000 cubic metres per day and 79,935, 000 cubic metres per annum. There will be no change in any other conditions.

The proposed variations represent no change from the total quantities presently authorised to be abstracted at these locations. The proposed variations allow for flexibility within the licensed quantities to allow a greater proportion to be treated at the Company's Little Eaton Water Treatment Works rather than at Church Wilne Treatment Works. This is in line with the Company's strategy for securing water supplies in the East Midlands.
