Stopping-up of Highways

The Sccretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of an area of highway land adjacent to the Hare and Hounds Public House, Grange Hill, Greenstead Green, Halstead, Essex
