#### TOWN AND COUNTRY PLANNING ACT 1990

## HIGHWAYS AGENCY

### ROAD TRAFFIC REGULATION ACT 1984 SECTION 6

*The A406 Trunk Road (Hanger Lane and Ashbourne Road, Ealing) (Prohibition of Right Turn) Order 1998*

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that on 4th February 1998, he made the above-named Order, the effect of which is to prohibit

- (a) northbound traffic in Hanger Lane from turning right into Ashbourne Road, and
