ROAD TRAFFIC REGULATION ACT 1984

The A6 Trunk Road (Haddon Road, Bakewell) 30 and 40 miles per hour Speed Limit Order 199

The Secretary of State for the Environment, Transport and the Regions gives notice that he proposes to make an Order under sections 82(2), 83(1) and 84(1)(a) and 2 of and paragraph 27 of Schedule 9 to the Road Traffic Regulation Act 1984.

If made as proposed the Order will impose a:

- (a) 40 miles per hour speed restriction on the A6 Trunk Road, Haddon Road in the District of Derbyshire Dales from a point 59 metres south of Burton Close Drive to a point 152 metres south of Intake Lane; and
- (b) 30 miles per hour speed restriction on the said trunk road from a point 25 metres south-east of Woodside Drive to a point 59 metres south-east of Burton Close Drive.

The Derbyshire County Council (Built-Up-Areas) Order 1936 is amended by the deletion of Schedule 1 item 1.

ROAD TRAFFIC REGULATION ACT 1984

The A449 Trunk Road (Chester Road North, Kidderminster) (No Right Turn) Order 1998

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984 on the A449 Trunk Road known as Chester Road North at Kidderminster in the County of Hereford and Worcester.

The effect of the Order is to prohibit vehicles other than those providing a local bus service to make a right turn from the A449 Trunk Road into the C2199 Hurcott Road (West).

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any Instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 9th March 1998, apply to the High Court for the suspension of or quashing of the Order or of any provision contained therein.
