Disabled Persons Parking Place in Bartholomew Close

Notice is hereby given that the Common Council of the City of London on 20th March 1998, made:

- (a) the City of London (Free Parking Place) (Disabled Persons) (No.3) Order 1998, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985;
