Westminster, March 25.

'Tis advised from Venice, March 12. Corfu, that the Seudo della fede, a Ship of War of the third Rate, belonging to this Republick, which was careening in the Port of Guin, was blown up by Accident, and only the Captain and two of the Men saved. This Day General Schulenbourg set out Post from hence for Otranto, where two Gallies wait for him: He is to stop at Rome, to press the Pope to haften the Affistance which he defigns to fend into the Levant this Sum-The Great Duke's two Gallies are fitting out, but we have no certain Account yet, when those of Genoa and the Squadrons from Spain and Portugal may be expected. On the 3d Instant a Convoy failed from Malamocco for Corfu, with two third Rate Men of War; on the 4th, a first Rate Man of War was launched, and in four or five Days two others of the same Rate will come out of the Arsenal. On Sunday last the Great Council chose Sig. Nicholas Foscarini Procurator of St. Mark. Barks are arrived from Verona, with 600 Swifs, and more are expected daily, to recruit the Regiments in the Service of this Republick. By a Vessel arrived from Dalmatia we have Advice, that one of our Parties having made an Incursion into the Enemy's Country, was returned with great Booty.

Madrid, March 15. The Deputies of the Clergy have frequent Conferences with the President of the Crusada, about adjusting the Subsidy demanded of all the Ecclesiasticks of the Kingdom; and that President has already remitted a confiderable Sum to Sig. Patinno, towards the Expence of building some Men of War in the Potts of Andalusia. On the 11th Instant at Night an Order was sent to M. Burlet, the King's

Berlin, March 23. Letters from Warfaw of the 16th, and from Great Poland of the 19th Instant, say the Provincial Dyets in those two Places had been quietly ended, and the late Treaty of Pacification approved. Advices from the Frontiers of the last Date mention, that the Muscovite Dragoons under General Bauer, which had been actually on the March further into Poland, were returned to their old Quarters, where it was faid they would stay till the Grass was up; but that the Foot which came from Mecklenbourg, would proceed directly to Livonia. On the 20th Instant Lieutenant General Schmettau arrived here from Saxony, from whence 'tis advised that the Saxon Army is to be reduced to ten thousand Foor and four thousand Horse and Dragoons, by breaking two Companies of each Regiment and lessening the private Men of the others; but none of the Regiments will be reformed, except those which were only raised for the Garrisons in Saxony during the late Troubles in Poland.

Hague, March 30. On the 27th Instant the Czar went to view the Apartments of the States of Holland, and tho' those States were at that Time affembled, yet the Doors were fet open, and his Majesty entering, the Assembly rose from their Seats to compliment him; after half an Hour's Discourse with some of the Deputies, he withdrew. On the 18th his Czarish Majesty went to Leiden, and returned hither. To Morrow he designs to go to Rotterdam, and thence to Zealand. The Count de la Marcq arrived here on the 27th at Night, and is to stay a few Days to confer with the Deputies of this State and some Foreign Ministers, before he proceeds to Sweden.
