(v) for the pursuance of mitigating any adverse effect which the existence or use of the highways proposed to be constructed or improved by him will have on their surroundings

The A45 Trunk Road (Packington Crossroads Junction Improvement) (Closure of Gaps in Central Reservation) Order 1998 This is an Order under sections 1(1) and 2(1) and 2(2) of the Road Traffic Regulations Act 1984, which if made, would close the gaps in the central reservation of the trunk road opposite its junctions with the Birmingham Road B4104 and the entrance to Packington Estates

Objectors are reminded that the substance of any objection or representation may be communicated to other people who may be affected by it, that it will be passed to the Inspector holding the inquiries and that he may be required to disclose at the inquiries the objection or representation and, unless there are specific reasons to the contrary, the identity of the author

The Secretary of State for the Environment, Transport and the Regions hereby directs that any person who intends at the inquiries to submit
