The A34 Trunk Road (North Hinksey to Botley Interchange) (50 m p h speed limit) Order 1998

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he made this Order on 14th September 1998, coming into force on 22nd September 1998, on the A34 Trunk Road in the county of Oxfordshire. Its effect is to impose speed limits on the A34 Trunk Road as follows

Northbound carriageway, from a point 600 metres south-east of the junction with Westminster Way to a point 450 metres north of the northern overbridge at Botley Interchange (A420)

Southbound carriageway, from a point 410 metres north of the northern overbridge at Botley Interchange to a point 760 metres south-east of the junction with North Hinksey Lane

This confirms and extends the 50 m p h speed restriction on this length of the A34 currently imposed by an experimental Order
