The existing consented discharge of up to 1,000 cubic metres per day of primary treated sewage from Hoo Waste Water Treatment will cease.

The application is for the discharge of screened and settled sewage which would take place in an emergency caused by total power failure or mechanical failure, or during a storm event when the flow to the pumping station exceeds 30 litres per second and the storage capacity of the storm tanks have been exceeded. The pumping station will be equipped with telemetered alarms for power failure and mechanical failure, standby pumps and a standby generator.

*Priority (Red) Route Measures on A214 Gleneagle Road, Ambleside Avenue, Tooting Bec Gardens and Tooting Bec Road and adjacent side roads*

2 The general nature and effect of the Orders will be to

- (a) introduce new Priority (Red) Route controls
  - (i) on the A214 Gleneagle Road, Ambleside Avenue, Tooting Bec Gardens and Tooting Bec Road, and
  - (ii) on parts of Babington Road, Gleneagle Road, Mitcham Lane, Rydal Road, Garrad's Road, Fernwood Avenue, Campbell Close, Prentis Road, at or near the junctions of those roads with the A214 and on the carriageway which links Tooting Bec Road with Tooting Bec Gardens, and which lies immediately opposite No 55 Tooting Bec Gardens,
- (b) to suspend the banned right turn by vehicles from Ambleside Avenue into Mitcham Lane,
- (c) to provide a cycle lane on the north-east side of Garrad's Road between Prentis Road and Tooting Bec Gardens (all vehicles, except pedal cycles, will be prohibited from entering or proceeding in this cycle lane)

3 The Executive Director of Environmental Services, or some other person authorised by him, may modify or suspend the Orders or any provisions therein if it appears essential to do so for certain purposes and he has obtained the consent of the Traffic Director for London

4 In due course the Lambeth Borough Council, with the consent of the Traffic Director for London, will be considering whether or not the provisions of the Experimental Orders should be continued in force indefinitely. Within the period of 6 months from the coming into force of the Orders, or if the Orders are subsequently varied by another Order under section 9 or modified pursuant to section 10(2) of the Road Traffic Regulation Act 1984, from the coming into force of that variation or modification (whichever is the latest), any person may object to the making of Orders to continue indefinitely those provisions. 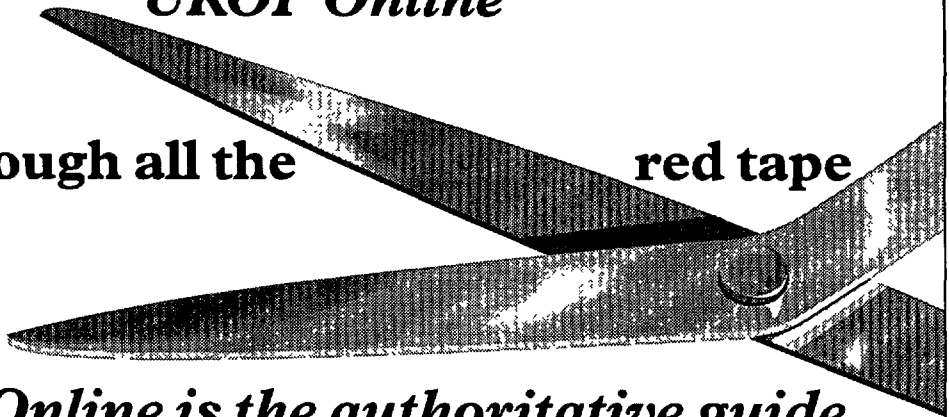

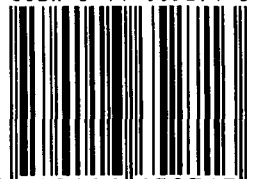
