### LAND COMPENSATION ACT 1973 (AS AMENDED)

#### *Notice of Opening*

Claims may be made 12 months after the new or altered highway is first open to public traffic, that is on or after 28th October 1998 (the "first claim day") Claims should be made within 6 years from this date However, any person who within the 12 months preceding that date makes a contract for disposing of their interest or (insofar as the interest is in land which is not a dwelling) for granting a tenancy may make a claim within that period and must do so before the interest is disposed of or the tenancy granted Compensation in such cases will not be payable before the first claim day
