

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising in the lengths of streets referred to in sub-paragraph (a) above, will be prohibited,

(e) the hours during which the existing prohibition applies on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that it will apply at any time in the length of street specified in Schedule 2 to this notice,

(f) the hours during which the existing prohibition applies on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be changed so that it will apply throughout the week in the length of street referred to in sub-paragraph (e) above

3 The prohibitions referred to in paragraph 2(a) and (b) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or a parking attendant or in certain circumstances, e.g., the picking up or setting down of passengers, the carrying out of statutory powers or duties, the taking in of petrol, etc., from roadside petrol stations, to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply

Notice is hereby given that the Council of the London Borough of Enfield

(a) has approved under section 23 of the Road Traffic Regulation Act 1984, the provision of a "Zebra" pedestrian crossing in *Eastfield Road* which will be situated opposite or adjacent to *Eastfield Primary School*,

(b) proposes to make the *Enfield (Prohibition of Stopping Outside Schools) (Special Parking Area) (Amendment No.) Order 1999*, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991

The general effect of Order would be to amend the *Enfield (Prohibition of Stopping Outside Schools) (Special Parking Area) (No. 1) Order 1995*, so that the restrictions imposed by that Order which apply in the lengths of *Bell Lane* and *Eastfield Road* specified in Schedule 1 to this notice would cease to apply thereto, and instead such restrictions would apply during school term-time between 8.15 a.m. and 9.15 a.m., between 11.30 a.m. and 1.30 p.m. and between 2.45 p.m. and 4 p.m. on Mondays to Fridays inclusive in the lengths of *Bell Lane* and *Eastfield Road* specified in Schedule 2 to this notice
