Sr. James's, May 17. On the 2d Instant the General Assembly of the Church of Scotland met at Edinburgh, and chose for their Moderator Mr. William Mitchell. His Majesty's Commission to the Right Honourable the Earl of Rothes was read, as was likewise His Ma-jesty's most gracious Letter to the Assembly. His Majesty's High Commissioner made a Speech to the Assembly, which was answered on their Part by the Moderator; and a Committee was appointed to draw up a Dutiful Answer to His Majesty's most gracious Letter, which being reported on the 4th, was unani-moufly approved; and having been transmit-ted by the High Commissioner to his Grace the Duke of Roxburghe, one of His Majesty's Principal Secretaries of State, has been presented to His Majesty, and is as follows.
