Notice is hereby given that the Council of the London Borough of Enfield, propose to make the Enfield (Short-term Parking Places) (Various Roads, Enfield) (Special Parking Area) (No) Order 199 and the Enfield (Restriction of Waiting on Bus Stops) (Special Parking Area) (No 1, 1997) (Amendment No) Traffic Order 199, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991

2 The general effect of Short-term Parking Places Order would be to (a) designate a free parking place in the length of Windmill Hill specified in Schedule 1 to this notice in which vehicles authorised by the Order may be left for a period of one hour, without charge, between 8 a m and 6 30 p m on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted),

(b) provide that no vehicle which has left the parking place referred to in sub-paragraph (a) above may return to that parking place within a

period of one hour,

(c) specify, in respect of the parking place, that passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles or invalid carriages may be left therein,

(d) provide that certain other vehicles may wait in the parking place in certain circumstances

3 The general effect of the Restriction of Waiting on Bus Stops Order would be to amend the Enfield (Restriction of Waiting on Bus Stops) (Special Parking Area) (No 1) Order 1997, so that

(a) vehicles would be prohibited from stopping at any time on the areas of carriageway of the street specified in Schedule 2 to this notice and which areas would be marked on the carriageway by a yellow "bus stop"

marking and by a solid yellow line,

(b) any existing restrictions on waiting by vehicles, on the sale of goods and on advertising activities imposed by the Enfield (Restriction of Waiting on Bus Stops) (Special Parking Area) (No 1) Order 1994 in the lengths of street specified in Schedule 3 to this notice would cease to apply thereto

4 The prohibitions referred to in paragraph 3 above would not apply

(a) to a bus, whilst picking up or setting down passengers, or

(b) to a taxi, whilst picking up or setting down passengers, or

(c) to a vehicle being used for ambulance, fire brigade or police purposes, or

(d) in certain circumstances, to a vehicle being used in the service of a local authority, to a vehicle being used in connection with building operations, etc., adjacent to the bus stop or the removal of any obstruction to traffic or the repair, etc., of the highway or of any service therein, or

(e) where the person in control of the vehicle is required by law to stop, or does so in order to avoid an accident, or

(f) to anything done with the permission of a police constable in

uniform or a parking attendant

Notice is hereby given that the Council of the London Borough of Enfield propose to make the Enfield (Waiting and Loading Restriction) (Special Parking Area) (Amendment No) Order 19 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and the Road Traffic Act 1991

The general effect of the Order would be further to amend the Enfield (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that

(a) the existing restrictions on waiting by vehicles, on the sale of goods and on advertising activities in the lengths of street specified in Schedule 1 to this notice imposed by the above mentioned Order of 1994 would be revoked,

(b) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited, (i) at any time in the lengths of streets specified in Schedule 2 to this Notice.

(ii) between 8 a m and midnight throughout the week in the lengths of street specified in Schedule 3 to this notice,

(iii) between 8 a m and 6 30 p m on Mondays to Saturdays inclusive in the length of street specified in Schedule 4 to this notice,

(c) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be prohibited

(1) between 11 a m and 6 30 p m throughout the week in the lengths of streets referred to in sub-paragraph (b)(1) and (b)(1) above,

(ii) between 11 a m and 6 30 p m on Mondays to Saturdays inclusive in the length of street referred to in sub-paragraph (b)(iii) above,

(d) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraph (b) above would be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Enfield Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected,

(e) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising in the lengths of streets referred to in sub-paragraph (b) above, would be prohibited,

(f) the hours during which the existing prohibition applies on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be changed so that it would apply at any time in the length of street specified in Schedule 5 to this notice

The prohibitions referred to in paragraph 2(b) and (c) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the
