THE BARNET (PRESCRIBED ROUTE) (EXPERIMENTAL) (NO. 1) TRAFFIC ORDER 1999

Notice is hereby given that the Council of the London Borough of Barnet on 27th April 1999, made the above-mentioned Order under section 9 of the Road Traffic Regulation Act 1984, as amended by section 8 and Schedule 5 of the Local Government Act 1985, and the Road Traffic Act 1991, and all other enabling powers

The general nature and effect of the Order will be to ban the following vehicle movements at the High Road/Churchfield Avenue N 12

(a) northbound traffic on High Road N 12 will not be permitted to turn right into Churchfield Avenue with the exception of pedal cyclists who use the gap in the central reservation,

(b) westbound traffic in Churchfield Avenue N 12 will not be able to turn right into the High Road N 12. This ban includes pedal cyclists The Order provides that, subject to the provisions of section 10(2) of the Road Traffic Regulation Act 1984, the Council's Chief Executive or some person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient or safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by this Order runs, modify or

suspend the Order or any provision thereof

Any person desiring to question the validity of the Orders, or any of their provisions contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof, or of any relevant regulations made thereunder has not been complied with in relation to the Orders may, within 6 weeks of the date on which the Orders are made, make application for the purpose to the High Court

If the provisions of the Orders continue in operation for a period of not less than 6 months, the Council will consider in due course whether or not the provisions of the Orders should be reproduced or continued in force indefinitely by means of Orders under section 6 of the said Act of 1984 Anyone who wishes to object to the making of such Orders for the purpose of such reproduction and continuation in force may, within the period of 6 months referred to above, send a statement in writing of their objection and the grounds thereof to the Traffic section, London Borough of Barnet, Barnet House, 1255 High Road, London N20 9EJ

(viii) any person causing a vehicle to proceed south-eastbound in Oak Grove in the London Borough of Barnet shall not cause that vehicle to turn right into Ash Grove N W 2,

(ix) any person causing a vehicle to proceed north-eastbound in Cricklewood Lane in the London Borough of Barnet shall not cause that vehicle to turn right into Oak Grove N W 2,

(x) any person causing a vehicle to proceed south-westbound in Cricklewood Lane in the London Borough of Barnet shall not cause that vehicle to turn left into Oak Grove N W.2
