#### KINGSTON TOWN CENTRE-BUS PRIORITY MEASURES, BATH PASSAGE

Notice is hereby given that the Council of the Royal Borough of Kingston-upon-Thames proposes to make the above-mentioned Order under section 6 and 124 of the Road Traffic Regulation Act 1984, (as amended)

The general effect of the Order would be to further amend the Kingstonupon-Thames (Free Parking Places) (Goods Vehicles) (Special Parking Area) (No 1) Traffic Order 1994, so that the goods vehicle loading bay situated on the north side of Bath Passage (adjacent to St James's Road) would be adjusted to between a point 27 metres west of the western kerb-line of St James's Road and a point 3 5 metres west of that point, bounded on the south side by an imaginary line drawn 7 metres north of the northern boundary of No 20 St James's Road and which has a width throughout of 5 metres

Notice is hereby given that the Royal Borough of Kensington and Chelsea, on 23rd July 1999, made the above-mentioned Order under sections 9, 10 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended by section 8 and Part I of Schedule 5 to the Local Government Act 1985 and of all other powers thereunto enabling

The effect of the Order will be to bring into force the experimental southbound contra-flow cycle lane in Gilston Road between Priory Walk and The Boltons

A copy of the Order, which will come into operation on 6th August 1999, and all other relevant documents (including a plan showing the layout of the cycle lane and the Council's statement of reasons) may be inspected during normal office hours on Mondays to Fridays inclusive until the date to which the effect of the Order ceases at

Any persons desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulations Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court

If the provisions of the Order continue in force for a period of not less than 6 months, the Council will consider in due course whether the provisions of the Order should be reproduced and continued in force indefinitely by means of an Order made under section 6 of the said Act of 1984

Any person wishing to object to the making of the Order under section 6 Order of the Road Traffic Regulation Act 1984, for the purpose of the indefinite continuation of the provisions of the Experimental Order, should send a statement in writing of their objection and the grounds thereof to the Director of Transportation and Highways, The Town Hall, Hornton Street, London W8 7NX, within a period of 6 months from the date on which the Experimental Order comes into force
