

THE BOROUGH OF ELMBRIDGE (KINGS ROAD, CRUTCHFIELD LANE AND HERSHAM ROAD, WALTON-ON-THAMES) (PROHIBITION OF VEHICULAR TRAFFIC) ORDER

1999

Notice is hereby given, that on the 30th July 1999, the Elmbridge Borough Council made an Order under sections 1, 2(1) to (3), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

This Order will come into operation on Tuesday 17th August 1999, whereupon no person shall cause or permit a vehicle to travel directly between Kings Road and Crutchfield Lane. Walton-on-Thames or between either of these two aforementioned roads and Hersham Road, Walton-on-Thames.

A copy of the Order and a map showing the restricted roads may be examined at the address given below, Monday to Friday between 9 a.m. and 5 p.m.

Any person who desires to question the validity of the Order, or any provisions contained in the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 30th July 1999, apply to the High Court for that purpose.

#### *Elmbridge Borough Council* the borough of elmbridge (off-street parking places) (halfway, walton-on-thames) order 1999

THE BOROUGH OF ELMBRIDGE (FREE ON-STREET-PARKING PLACES) (HALFWAY, WALTON-ON-THAMES) ORDER 1999

Notice is hereby given, that on the 30th July 1999, the Elmbridge Borough Council made the above-mentioned Orders under sections 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, effecting the system of parking controls in the area of Halfway, Walton-on-Thames. The Orders will come into operation on Monday 16th August 1999, whereupon their effect will be as follows:

(a) Halfway Public Car Park

To introduce within the off-street public Car Park at Halfway, Waltonon-Thames car parking charges between the hours of 9 a.m. and 6 p.m., Monday to Friday, such charges to be set at 10 pence per hour for up to four hours parking (no return within one hour). Contract parking at  $\pm 56.25$  per quarter or  $\pm 200$  per annum. Please note that the maximum number of season tickets to be issued is increased from 15 (as per the Notice published 25th February 1999) to 23.

(b) The existing Controlled Parking Zone covering Walton Station area and surrounding roads be extended to cover the Halfway area. The existing "Waiting Limited to One Hour" restriction in Hersham Road (which currently extends from outside No. 95 to outside No. 139) be amended to Monday to Friday 9 a.m. to 6 p.m., one hour free parking. Copies of the made Orders may be examined at the address given below between the hours of 9 a.m. and 4.30 p.m., Mondays to Fridays.

Any person who desires to question the validity of the Orders or any provisions contained in the Orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that or any instrument made under it has not been complied with in relation to the Orders, may within 6 weeks from 30th July 1999 apply to the High Court for that purpose.

#### High Peak Borough Council The high peak borough council (OFF-Street Parking places) (Modification no. 1) Order 1999
