Corporation of London **RESTRICTION ON STOPPING AT BUS STANDS AND BUS** STOPS IN THE CITY

Notice is hereby given, that the Common Council of the City of London propose to make an Order under sections 6, 7(1) and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984

The general effect of the Order would be to

(a) revoke the City of London (Restriction of Waiting on Bus Stops) (No 1) Traffic Order 1993.

(b) prohibit vehicles from stopping and remaining at rest between 7 a m and 7 p m throughout the week on any area of carriageway of any of the streets specified in the Schedule to this notice and which area would be marked on the carriageway by a yellow "bus stand" or "bus stop" marking and by a single yellow line

The prohibition would not apply

(a) to a bus being used for operational reasons whilst providing a London Bus Service under an agreement with London Regional Transport, or

(b) to a bus or taxi as defined in the Traffic Signs Regulations and General Directions 1994, whilst picking up or setting down passengers, or

(c) to a vehicle being used for ambulance, fire brigade or police purposes in an emergency, or

(d) in certain circumstances, to a vehicle being used in the service of a local authority, the removal or any obstruction to traffic or the repair, etc., of the highway or of any service therein, or

(e) where the person in control of the vehicle is required by law to stop or does so in order to avoid an accident, or

(f) to anything done with the permission or at the direction of a police constable in uniform

A copy of the proposed Order, of the above-mentioned Order of 1993 of the Common Council's statement of reasons for proposing to make the Order and of a plan showing the affected streets can be inspected during normal office hours on Mondays to Fridays inclusive within a period of 21 days from the date on which this notice is published in The Town Clerk's Department, Guildhall, London E C 2
