Pursuant to Regulation 5(8) of the above Regulations, the Secretary of State for Trade and Industry gives notice that, being content that the requirements of the above Regulations have been satisfied, he has, pursuant to Licence P960, granted a consent to Agip (UK) Ltd to the drilling of an exploration well in block 164/28 The consent for well 164/28-A took effect from 11th August 1999 Block 168/28 lies about 90 kilometres north-west of Lewis in a water

Block 168/28 lies about 90 kilometres north-west of Lewis in a water depth of about 850 metres The closest median line (Faroes) is 90 kilometres north of the site Transboundary effects are considered to be negligible

The area is relatively unexplored, with the nearest commercial fields (Foinaven and Schiehallion) being 220 kilometres north-east Three wells are within a 40 kilometre radius, the nearest 17 kilometres distant, cumulative effects are considered negligible for atmospheric emissions, accidental hydrocarbon discharges and mud/cuttings discharges

The rig is expected to be on site for 56 days, if hydrocarbons are found and the well tested, the rig may remain for a further 10-20 days Rig selection has not been finalised at the time of ES production, hence anchor number and mooring pattern is not known The well is more likely to be oil rather than gas
