The Secretary of State is of the view, having regard to the environmental statement prepared in respect of the well and the comments received from those consulted, that the project is not likely to have a significant effect on the environment. The environmental statement adequately assessed the potential environmental impacts of drilling in a sensitive area and showed that all necessary contingency measures will be put in place (10 SI)
