Notice is hereby given that on 18th November 1999, Newcastle City Council made an Order under sections 9, 10 and Schedule 9 of the Road Traffic Regulation Act 1984.

2. The effect of the Order, which will come into force on 3rd December 1999 is as follows:

(a) to prohibit cars from proceeding between the hours of 7 a.m. and 7 p.m. in existing bus lanes or bus/goods vehicle/cycle priority lanes on Barras Bridge, Byker Bridge, westbound Coast Road slip road (from Chillingham Road), Gallowgate, Great North Road (between slip road from A167 (M) and Barras Bridge), Market Street, New Bridge Street (including westbound slip road onto New Bridge Street roundabout at Central Motorway East), St. Mary's Place (westbound), Sandyford Road, Shields Road West and Westgate Road.

(b) to prohibit cars from proceeding between the hours of 7 a.m. and 7 p.m. on the inside lane of:

(i) Percy Street (southbound) from Barras Bridge southwards for 40 metres;

(ii) St. Mary's Place (eastbound) between Barras Bridge and John Dobson Street;

(c) to prohibit cars from entering the unnamed road linking New Bridge Street roundabout and Market Street, eastbound from Market Street and westbound from New Bridge Street roundabout.

(d) to prohibit cars from entering the following roads between 7 a.m. and 7 p.m., Neville Street from Bewick Street, Brinkburn Street/Corbridge Road Bus Link Road from Conyers Road, Brinkburn Street (south) from Corbridge Street, Grainger Street (north of Nun Street) from Grainger Street (south of Nun Street), Neville Street from Grainger Street, Grainger Street from Neville Street, Glamis Avenue from Great North Road, Heaton Road (south of North View) from New Denmark Street and North View, Heaton Road from Shields Road and St. Cuthberts Road from West Road.

(e) to prohibit cars from proceeding between 7 a.m. and 7 p.m. on Newgate Road (southbound) from a point 8.9 metres south of the south kerb-line of Low Friar Street.

3. For the purposes of this Order the wording car means a mechanically propelled vehicle, not being a motor cycle or an invalid carriage or a licensed hackney carriage or private hire vehicle or being constructed or adapted for use for the conveyance of goods or burden of any description, which is constructed itself to carry not more than seven passengers and their effects and of which the weight unladen does not exceed 3,050 kilograms.

4. The existing restrictions in respect of 2(a), (c), (d) and (e) above are suspended for the duration of this Order. The existing restrictions imposing a ban on the left-hand and right-hand turns from Grainger Street into Newgate Street are also suspended for the duration of the Order.

5. The Order is required to increase accessibility and reduce delays for public transport entering the city.

6. A copy of the Order, together with a map and a statement of the Council's reasons for proceeding by way of experiment and of its intention to consider making a permanent Order in like terms, may be examined at the offices of the Planning and Transportation Division (6th Floor), Civic Centre, Newcastle upon Tyne, between the hours of 8.30 a.m. and 4.30 p.m. Copies may be purchased at a reasonable charge. 7. The Order will be in force for a period not exceeding 18 months during which time consideration will given to the making of a permanent Order in like terms.

8. If you wish to object to the possibility of the Order being made permanent, you should send the grounds for your objection in writing to the undersigned not later than 3rd June 2000, quoting Ref. GH/P44/363.

9. Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the relevant enabling Act or that a requirement of any such enabling Act or of any relevant regulations made thereunder has not been complied with may, within 6 weeks commencing on 18th November 1999, make application for this purpose to the High Court.
