ROAD TRAFFIC REGULATION ACT 1984

THE A65 TRUNK ROAD (HELLIFIELD) (30 AND 40 MILES PER HOUR SPEED LIMIT) ORDER

The Secretary of State for the Environment, Transport and the Regions gives notice that he proposes to make an Order under section 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984.

The Order if made as proposed will:

(i) extend the existing 30 m.p.h. speed restriction 117 metres at the eastern end of the village, from a point 19 metres west of the centre line of the junction with the road to Airton to a point 44 metres east of the centre line of the junction with Thorndale Street, and

(ii) introduce a 40 m.p.h. speed restriction on a 280 metres section between the existing 30 m.p.h. speed restriction and the derestricted section at the western end of the village, from a point 293.2 metres west of the centre line of the junction with Brook Street to a point 60 metres south-east of the centre line with the junction of the road leading to Gallaber Farm.
