

Kirklees Metropolitan Council**NEW ROADS AND STREET WORKS ACT 1991, SECTION 58
NOTICE OF SUBSTANTIAL ROAD WORKS**

Three months advance notice is hereby given that Kirklees Metropolitan Council—Highways Service intends to carry out substantial road works.

The streets in which these works will take place are A6024 Woodhead Road, Holme, near Holmbridge.

Work is expected to affect the carriageway/footway between: from The Holme Castle Hotel to a point 1350 metres to south of The Holme Castle Hotel.

Work is expected to commence on 14th May 2000, (works should begin within one month of this date).

The works notified will include the following: Carriageway and Footway Reconstruction/Resurfacing, some Kerbing, Walling and Drainage Works.

Subject to exemptions in the Act and Regulations under it, no street works may be executed for a period of 12 months from completion of works described in paragraph 5 without the consent of the said Highway Authority which shall not be unreasonably withheld.

(NO. 1) ORDER 2000**

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that, on the application of the Ministry of Defence he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highway (County of Norfolk) (No. 1) Order 2000" authorising the stopping-up of an area of all purpose highway on land at Grange Crescent, RAF Marham, King's Lynn, Norfolk to enable development consisting of construction of two buildings to be used as living accommodation by junior ranks airmen at RAF Marham, King's Lynn, Norfolk to be carried out in accordance with the notice of proposed development submitted by the Ministry of Defence to King's Lynn & West Norfolk Borough Council and to which the Council gave notice on 9th September 1999 under Ref. 2/99/0896/SU that they have no objections.

Mobil North Sea Limited has submitted, for the consideration of the Secretary of State for Trade and Industry, a draft Decommissioning Programme for the Camelot CB platform (UKCS 53/2) in accordance with the provisions of the Petroleum Act 1998. It is a requirement of the Act that interested parties be consulted on such decommissioning proposals.

The facilities covered by the Decommissioning Programme are the removal of topside facilities and jacket, and clearance of the seabed in the immediate vicinity.
