THE NEWHAM (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. 46) ORDER

#### BALAAM STREET/HIGH STREET, PLAISTOW/BROADWAY **LONDON E.13**

Notice is hereby given that the Council of the London Borough of Newham on 8th May 2000 made the above mentioned Order under sections 6 and 124 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

The general effect of the Order will be to introduce new restrictions on waiting by vehicles (including for the purpose of delivering or collecting goods or loading or unloading a vehicle) "at any time" (double yellow lines and loading blips) in the lengths of roads specified in the Schedule to this notice, i.e., the Balaam Street/Broadway E.13/High Street, Plaistow Junction.

## MILL ROAD, ILFORD

- The general effect of the orders will be as follows:
- (i) to provide on an experimental basis, a mandatory with-flow cycle lane to assist in the free movement of cycles in Mill Road; and
- (ii) to further amend on an experimental basis, the Redbridge (Waiting and Loading Restriction) Order 1993 in Mill Road to facilitate the above mentioned with-flow cycle lane.

Any person wishing to question the validity of the Orders or of any provisions contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Orders may,

within 6 weeks of the date on which the Orders were made, make application for the purpose to the High Court.

If the provisions of the Experimental Orders continue in operation for a period of not less than 6 months, the Council will consider in due course whether the provisions of the Orders should be reproduced and continued in force indefinitely by means of Orders under sections 6, 124 and Part IV of Schedule 9 of the said Act of 1984. Persons wishing to object to the making of the Orders under sections 6, 124 and Part IV of Schedule 9 of the said Act for the purpose of such reproduction and continuation in force may, within the aforementioned period of 6 months, send a statement in writing of their objection or representation and the grounds thereof to the Chief Legal Officer,. THE SUTTON (BUS STOPS) (RESTRICTION OF WAITING) (NO. 2) (AMENDMENT NO. 1) ORDER 2000

Notice is hereby given that the Council of the London Borough of Sutton made the above mentioned Orders on 9th May 2000, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, and the Road Traffic Act 1991.

(b) redefine the position of the bus stop restriction on the south side of Westmead Road in the vicinity of Carshalton Grove in order to provide a parking place adjacent to the western end of the bus stop restriction, whilst maintaining full access to the bus stop.

(Introduce limited time parking places—"waiting limited to 2 hours with no return within 4 hours between 8 a.m. and 6.30 p.m., on Mondays to Saturdays inclusive")

Westmead Road:

(a) the north side:

- (i) from a point 15 metres west of the western kerb-line of Kingsley Avenue westwards for a distance of 11 metres;
- (ii) from a point 19.5 metres west of the western kerb-line of Cowper Avenue westwards for a distance of 15 metres;
- (iii) from a point 7.2 metres west of the western kerb-line of Byron Avenue westwards for a distance of 11 metres; and
- (iv) from a point 9.3 metres east of the eastern kerb-line of Harold Road eastwards for a distance of 13.8 metres.
- (b) the south side:
- (i) from a point 3.5 metres west of the eastern flank wall of No. 83A Westmead Road eastwards for a distance of 11 metres; and
